Information on the processing of personal data

Pursuant to EU Regulation no. 679/2016 (so-called GDPR), the following information is provided regarding the processing of personal data of subjects who, during the COVID-19 emergency, so-called Coronavirus, access events organized by MEET AND WORK SRL, the premises and offices of MEET AND WORK SRL or other places, however, related to the latter.

Type of personal data processed and of interested parties

Within the limits of the purposes and methods defined in this information, the following are processed:

- a) data relating to body temperature;
- b) information relating to close contacts at high risk of exposure, in the last 14 days, with suspected subjects or positive for COVID-19;
- c) information relating to the origin, in the last 14 days, from areas at risk according to the indications of the WHO.

The personal data being processed refer to:

- a) MEET AND WORK SRL staff - With respect to these interested parties, this information supplement that already provided for the processing of personal data functional to the establishment and execution of the employment relationship;
- b) participants, speakers, moderators, sponsors, suppliers, transporters, contractors, visitors and any other third party authorized to access an event organized by MEET AND WORK SRL, the premises and offices of MEET AND WORK SRL or other places in any case referable **to the latter**.

Purpose and legal basis of the processing

Personal data will be processed exclusively for the purpose of preventing contagion from COVID-19 in execution of the anti-contagion security protocol adopted pursuant to art. 1, no. 7, lett. d) of the Prime Ministerial Decree of 11 March 2020 and subsequent amendments. The legal basis of the processing is, therefore, to be found in the implementation of the anti-contagion security protocols pursuant to art. art. 1, no. 7, lett. d) of the Prime Ministerial Decree of 11 March 2020 and subsequent amendments.

Nature of the provision of personal data

The provision of data is necessary to access an event organized by MEET AND WORK SRL or to access the premises and offices of MEET AND WORK SRL or other places in any case related to the latter. Any refusal to give them prevents you from allowing entry.

Method, scope and duration of the processing

The processing is carried out by the staff of MEET AND WORK SRL acting on the basis of specific instructions provided regarding the purposes and methods of processing. With reference to the measurement of body temperature, MEET AND WORK SRL does not make any data recording. The identification of the interested party and the recording of the exceeding of the temperature threshold could take place only if it was necessary to document the reasons that prevented access. In this case, the interested party will be informed of the circumstance.

Personal data will not be disseminated and may be disclosed to third parties only in the cases and in the manner provided for by the current provisions of the law (eg: reconstruction by the Health Authority of the supply chain of any close contacts of a subject who tested positive for COVID -19).

The data will be processed for the time strictly necessary to pursue the aforementioned purpose of preventing the contagion from COVID-19 and stored no later than the end of the state of emergency.

Rights of interested parties

At any time, interested parties have the right to access their personal data, to request their correction, updating and related cancellation. It is also possible to oppose the processing and request its limitation.
